



- Eligibility: Everyone with a valid fishing license is welcome to fish this event!
- Entry Fee: \$200 / two-person team– Maximum of 99 teams
- ALL ENTRIES ARE FINAL and NON-REFUNDABLE– No Exceptions**
- Event Date: May 15<sup>th</sup>, 2021 – Bad Weather Day May 16<sup>th</sup>, 2021
- App Deadline: May 14<sup>th</sup> 7PM CST @ Dakota Sioux Casino - Rules Meeting
- Fishing Time: 7AM-2PM CST
- Place: Bitter Lake
- Boundaries: Any area accessible by boat after launch unless deemed unlawful by South Dakota Law.
- Weather: Bad Weather will result in either the launch being moved or date to be changed to the following day. Directors have final say.
- Check In: All boats must check in at the Glacial Lakes Walleye League trailer at the State SE boat ramp. Inspections will be done by tournament directors before entering the water.
- Weigh In: Bring your best 5 walleyes to the scale, only 2 over 20” per team per state law. Scale will be open at 3PM CST at Dakota Sioux Casino. Teams must return to weigh in by water. At least 1 team member must report to the weigh-in even if the team does not have a fish to weigh. Boat must be in sight and off plane to be considered on time. Do not leave fish unattended until they are weighed. Official Tournament ruler/scale is the judge. Director’s decision is final in the weighing and measuring of fish. Teams deemed late will be disqualified.
- Check Boat: If you are contacted by a check vessel... **If you have a fish on**, wave both hands in the air until the fish is landed. **If you DO NOT have a fish on** wave 1 hand and the vessel will approach. You ARE NOT allowed to enter your live well for any reason while the check boat is approaching “Live Well Diving” is grounds for immediate disqualification. Culling is illegal in SD and all fisherman are expected to follow our laws.
- Laws: ALL STATE LAWS will be adhered to and under no circumstance will DSC/GLWL rules trump SDGFP law. Follow the law at all times. Children under age 17 must wear a PFD while on plane at all times.
- Sportsmanship: All contestants are expected to follow high standards of sportsmanship, courtesy, safety, and conservation. During the tournament, no other boats may come in contact with other contestant’s boats. Drunkenness at any official activity will be grounds for disqualification. Ties: In case of a tie, biggest walleye decides, coin flip second.
